Winter storage 1 October to 1 April

incl. crane costs, jetting the hull under the waterline to clean it and a support frame

If reservations are made before 1 October 2010 and the invoice is paid within 10 days of receipt, a discount of 3% will be given on the storage costs.

Storing mast in frame

- use of crane/forklift for uninstalling and installing mast 8.05 / m

Battery storage and maintenance

Batteries which are difficult to access can be serviced on board for an hourly fee.

Storage of outboard motor

Crane charges

- single, maximum of 4 hours in crane (min. €56.75) 6.00 / m²

Crane charges do not include picking up and bringing the boat back. If a yacht has an unusually thick layer of fouling, an extra fee will be charged for labour.

Antifouling (recommended prices)
